




# Prune or Remove a Tree

<p><b>Introduction</b></p>	<p>This form is required to prune or remove a tree on private property within the Ashfield municipality. Council will define a "tree" as meaning any woody plant with a <u>height greater than five (5) metres</u>. Some trees are excluded from this definition. Please read the back of this form to see if your tree is exempt. The approval process usually takes 10 working days from the date of lodgement. Approval is valid for 6 months from the date of approval. For further enquiries, please contact Council's Tree Management Section on 9716 1800.</p>

# Tree Preservation Order

A Tree Preservation Order applies to the whole of Ashfield Municipal Council. This prohibits the ring-barking, cutting down, topping, lopping, and removing, injuring or wilful destruction of any tree growing on any land within Ashfield Municipal Council, except with the written consent of the Council.

Council defines a "tree" as meaning any woody plant with a height greater than five (5) metres, but does not include the following three categories:

**CATEGORY A** - These trees are not considered significant to the environmental and amenity values of the Ashfield Municipality:

**CATEGORY B** - The trees listed below are exempt from the Tree Preservation Order subject to the following conditions:

a) The tree must be less than 10 metres in height or have a trunk diameter less than 450mm when measured 1.5 metres from ground level.

b) The tree must be within 3 metres of a dwelling or sewer line and causing damage. Dwellings do not include structures such as carports and pergolas.

**CATEGORY C** - The following prunings are exempt and consent is given conditional that the work is carried out in accordance with the Australian Standard AS4373 - 2007 Pruning of Amenity Trees and Workcover Code of Practice – Amenity Tree Industry.

- Maintenance of minimum clearance of 500mm from domestic power lines (as specified by Energy Australia)
- Pruning to remove deadwood/branches
- Minor pruning of branches directly overhanging the roof of any building to a height of 2 metres only with the agreement of the owner of the tree
- Trees overhanging a public road including footpaths for the purpose of removal of a hazard to a height of 2.4 metres above ground level.

**How a Tree Application is Determined**

In determining applications for tree removal or pruning, consideration will be given to:

- The condition of the tree with regard to disease, danger of falling limbs, proximity to existing or proposed structures, interference with utility services and amenity of neighbours.
- Necessity for removal or pruning in order to construct improvements to the property subject to approval of the development application.
- The number of trees existing in the neighbourhood and the effect the tree removal/pruning will have on the amenity of the area.
- The number of healthy trees that a given parcel of land will support.
