Tree Preservation Order

A person shall not, except with the consent of the Council, cut down, top, lop remove, injure or wilfully destroy any tree the subject of this Order, which has a height of more than 4 metres, where any one or more trunks have an diameter of 0.35m (at a height of 1 metre above the ground), or has a foliage crown spread of more than 4 metres.
